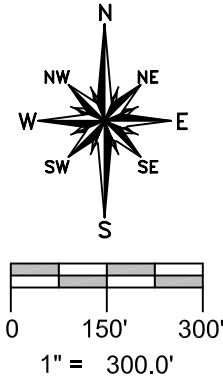


PLAT OF SURVEY

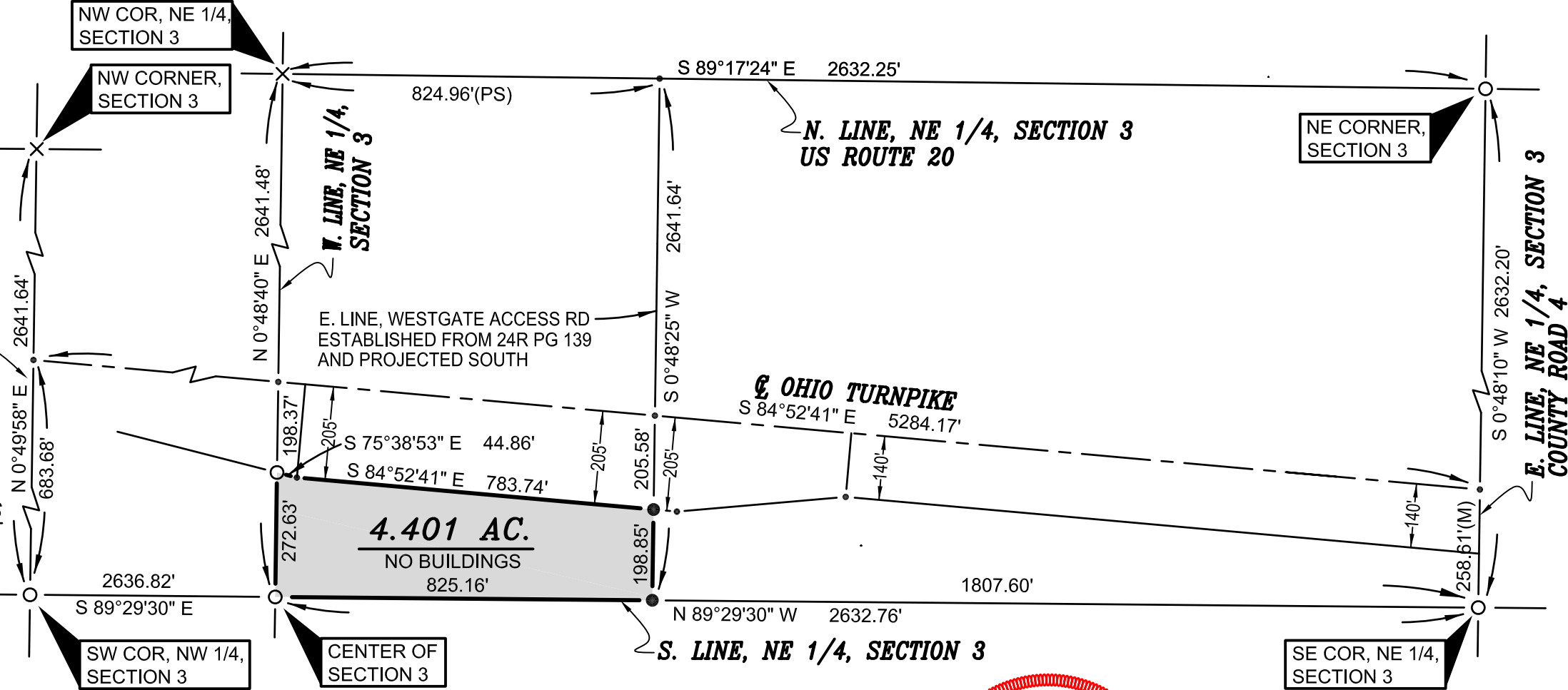

Random areas of fencing existed along the South line of this parcel. Turnpike right of way fencing existed along the Northern boundary of this parcel.

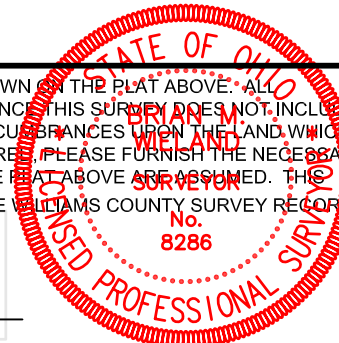
