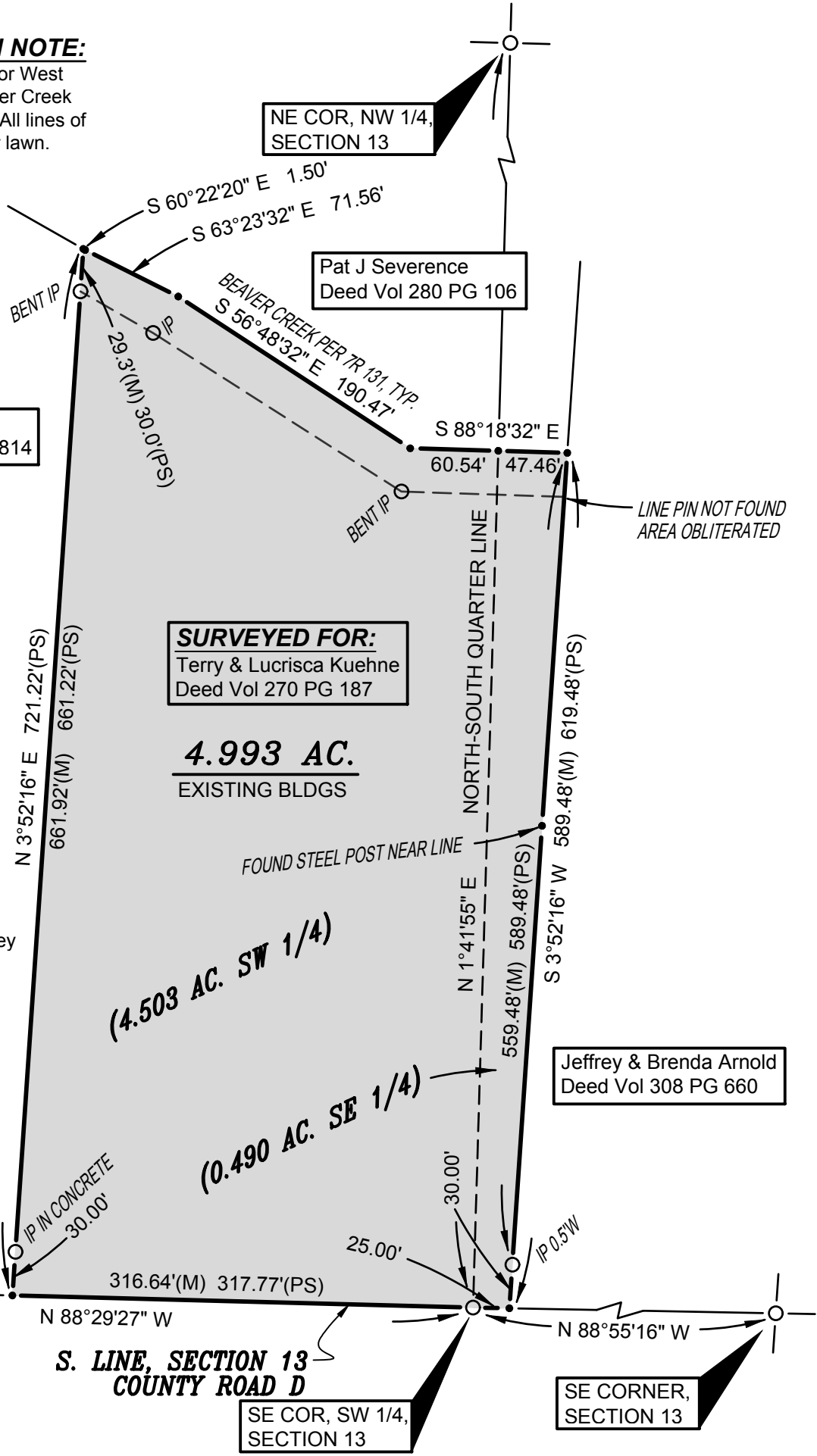


# PLAT OF SURVEY

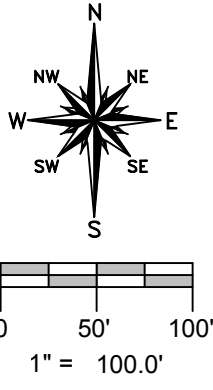

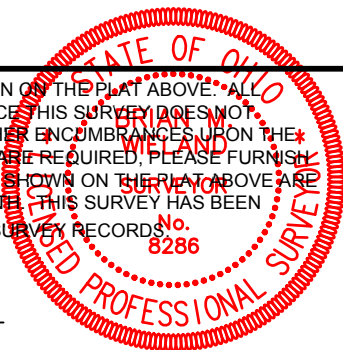
