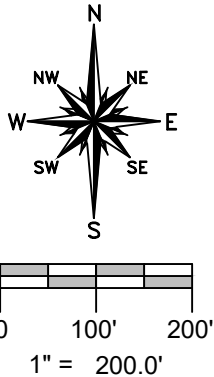


# PLAT OF SURVEY
