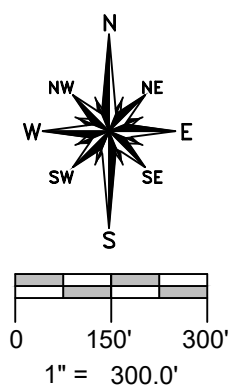


PLAT OF SURVEY

A PARCEL OF LAND SITUATED IN THE SOUTHWEST QUARTER OF SECTION 9, TOWN 7 NORTH, RANGE 3 EAST, JEFFERSON TOWNSHIP, WILLIAMS COUNTY, OHIO. LOCATED WITHIN THE NORTH AND EAST OF THE FIRST PRINCIPAL MERIDIAN OF THE ORIGINAL LAND SUBDIVISIONS OF OHIO.

GENERAL OCCUPATION NOTE:

Random areas of fence existed along portions of all boundary lines of this parcel. The occupation lines between the small exception and the large farm was agricultural/lawn with no fencing or other man-made occupational line.

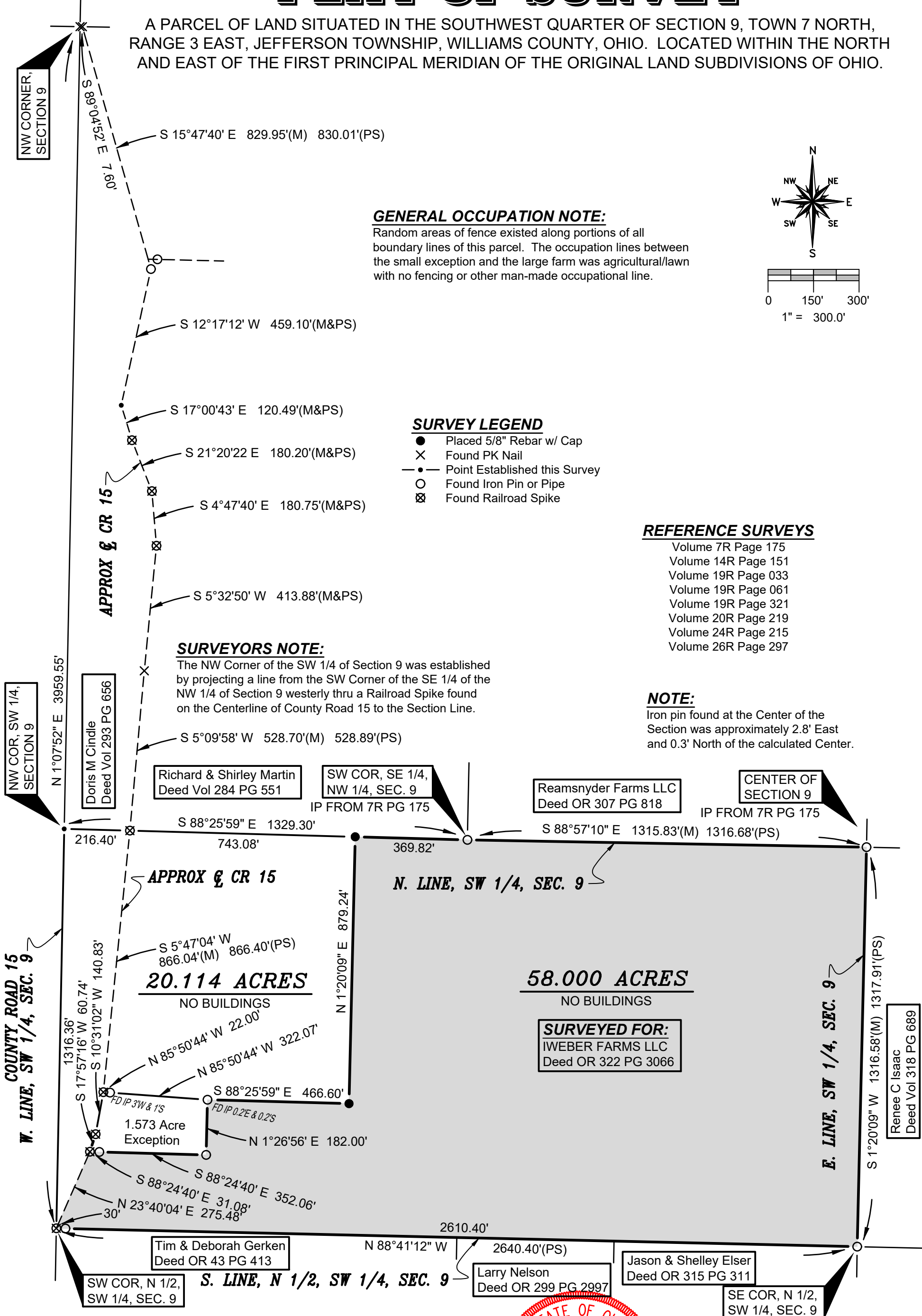

SURVEYORS NOTE:

The NW Corner of the SW 1/4 of Section 9 was established by projecting a line from the SW Corner of the SE 1/4 of the NW 1/4 of Section 9 westerly thru a Railroad Spike found on the Centerline of County Road 15 to the Section Line.

NOTE:

Iron pin found at the Center of the Section was approximately 2.8' East and 0.3' North of the calculated Center.

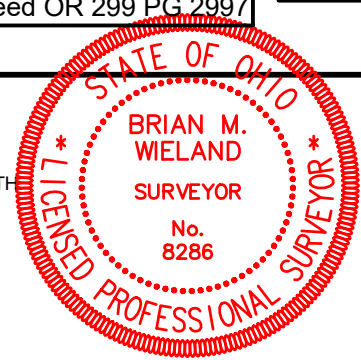
