

PARCEL 1 — 1.421 ACRES

Commencing at a railroad spike found marking the Northeast corner of the Northeast Quarter of Section 7;

Thence North 88°55' 45" West along the North line of said Section 7 a distance of 2,640.00 feet to a 5/8 inch rebar with ID cap set marking the Northeast corner of said Northwest Quarter and the Northwest corner of a 5.250 acre tract of land as recorded in Official Record Volume 351, Page 480 (Parcel 7) and Survey Record Volume 28R, Page 273 and the POINT OF BEGINNING;

Thence South 01°00' 59" West along the East line of said Northwest Quarter and the West line of said 5.250 acre tract a distance of 352.85 feet to a mag nail set on the centerline of County Road F marking the Southwest corner of said 5.250 acre tract;

Thence North 59°08' 39" West along said centerline a distance of 283.31 feet to a mag nail found marking the Southeast corner of a 1.06 acre tract of land as recorded in Official Record Volume 308, Page 414 and the Southeast corner of a 0.233 acre tract of land as recorded in Survey Record Volume 26R, Page 23;

Thence North 19°31' 11" East along the East line of said 0.233 acre tract a distance of 223.61 feet to a 5/8 inch rebar with ID cap found on the North line of said Section 7 marking the Northeast corner of said 0.233 acre tract, passing a 5/8 inch rebar with ID cap found at 30.00 feet;

Thence South 88°55′45" East along the North line of said Section 7 and the North line of said 112.66 acre tract a distance of 174.79 feet to the POINT OF BEGINNING, said tract containing 1.421 acres of land, more or less.

Commencing at a railroad spike found marking the Northeast corner of the Northeast Quarter of Section 7;

Thence North 88°55′45″ West along the North line of said Section 7 a distance of 2,145.00 feet to a point marking the Northeast corner of said 5.250 acre tract and the POINT OF BEGINNING, referenced by a 5/8 inch rebar found lying 0.34 feet North and 0.96 feet East of said point;

Thence South 01°01' 32" West along the East line of said 5.250 acre tract a distance of 526.49 feet to a mag nail found on the centerline of County Road F marking the Southeast corner of said 5.250 acre tract, passing a 5/8 inch rebar found at 495.99 feet:

Thence along said centerline the following six (6) courses:
