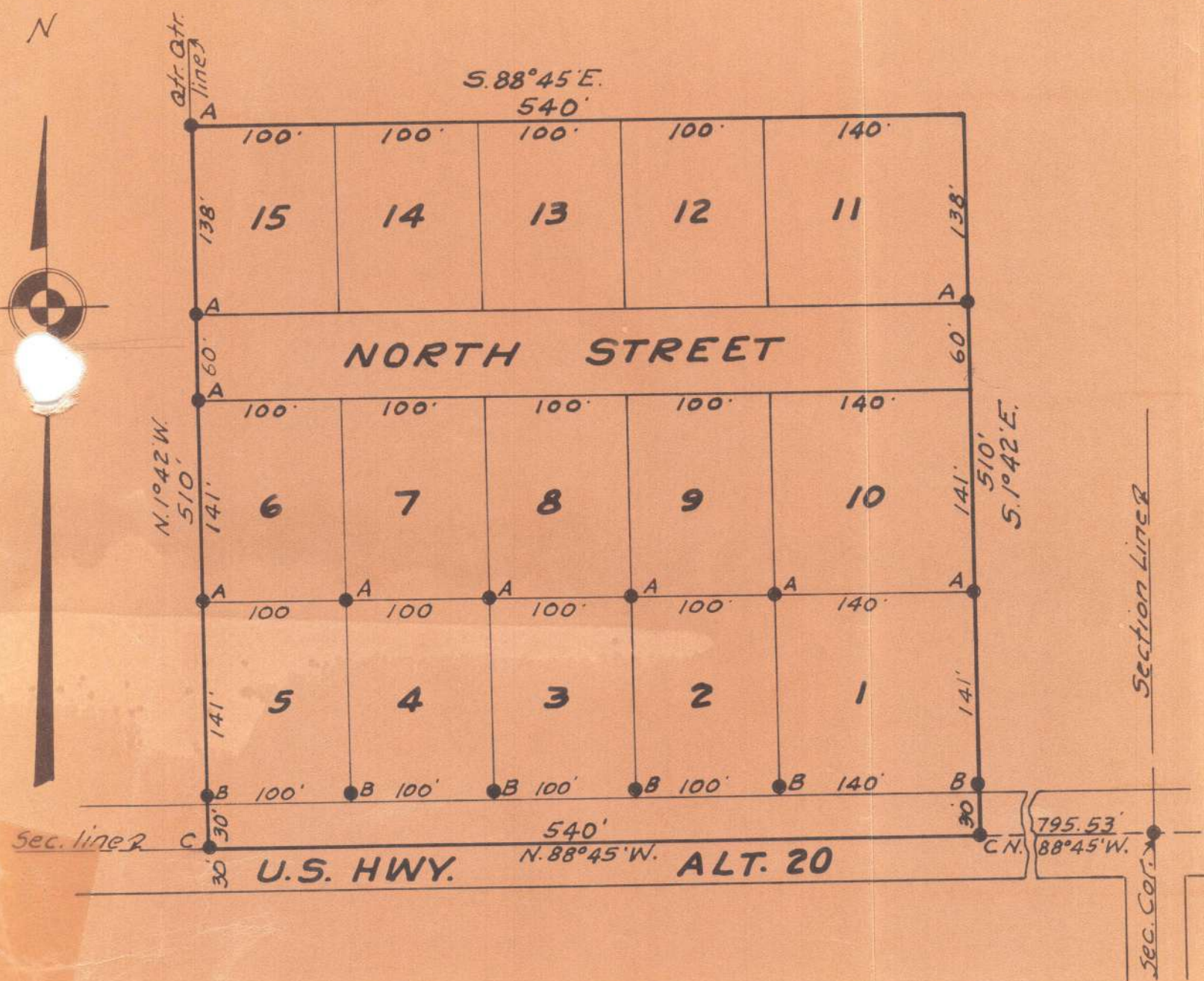


GLEN HARRIS SUBDIVISION

I hereby certify that on the 27th day of April and the 2nd 3rd 4th and of May 1960 I surveyed and Platted Glen Harris Subdivision in the South East $\frac{1}{4}$ of Section 5 Town 7 North, Range 4 East Brady Township, Williams County, Ohio; More particularly described as follows, Commencing at the South East corner of the South East $\frac{1}{4}$ of the above described Section; Thence North Eighty Eight Degrees Forty Five Minutes West (N. 88° 45' W.) and binding upon the section line a distance of Seven Hundred Ninety Five and Fifty Three Hundredths (795.53) feet to a large spike, and the place of beginning; Thence continuing North Eighty Eight Degrees Forty Five Minutes West (N. 88° 45' W.) and binding upon the section line, a distance of Five Hundred Forty (540) feet to a large spike; Thence North One Degree Forty Two Minutes West (N. 1° 42' W.) a distance of Five Hundred Ten (510) feet, to a metal surveyors stake; Thence South Eighty Eight Degrees Forty Five Minutes East (S. 88° 45' E.) a distance of Five Hundred Forty (540) feet to a point; Thence South One Degree Forty Two Minutes East (S. 1° 42' E.) a distance of Five Hundred Ten (510) feet to the place of beginning and containing (6.32) acres of land.
