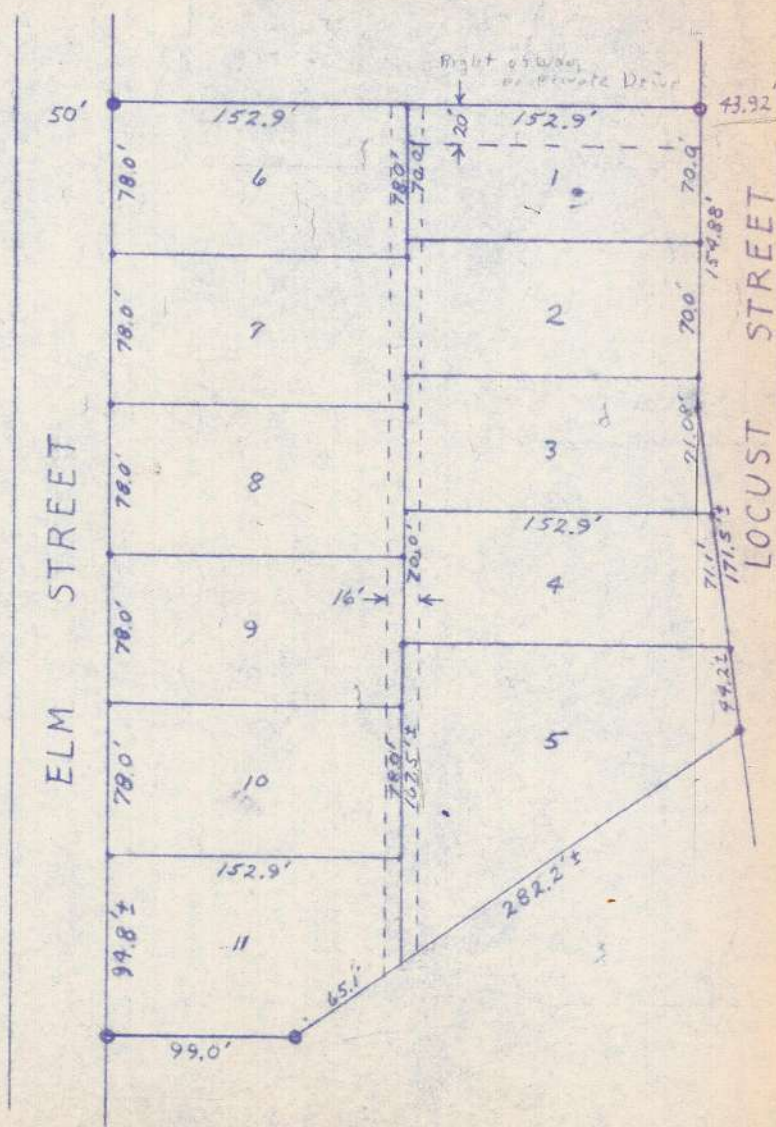


SIEBENALER'S ADDITION

DESCRIPTION

Commencing at a point One Hundred Thirty Two Feet (132') South and One Hundred Forty Three and Ninety Two Hundredths Feet (143.92') West of the Intersection of the South line of Sargent Street and the east line of Section Twenty Eight (28) thence West Three Hundred Five and Eight Tenths Feet (305.8'); thence South Four Hundred Eighty Four and Eight Tenths (484.8') more or less; thence East Ninety Nine Feet (99'); thence North easterly Two Hundred Eighty Two and Two Tenths Feet (282.2'); thence North westerly One Hundred Seventy One and Five Tenths Feet (171.5'); thence North One Hundred Fifty Four and Eighty Eight Hundredths Feet (154.88') to place of beginning.
