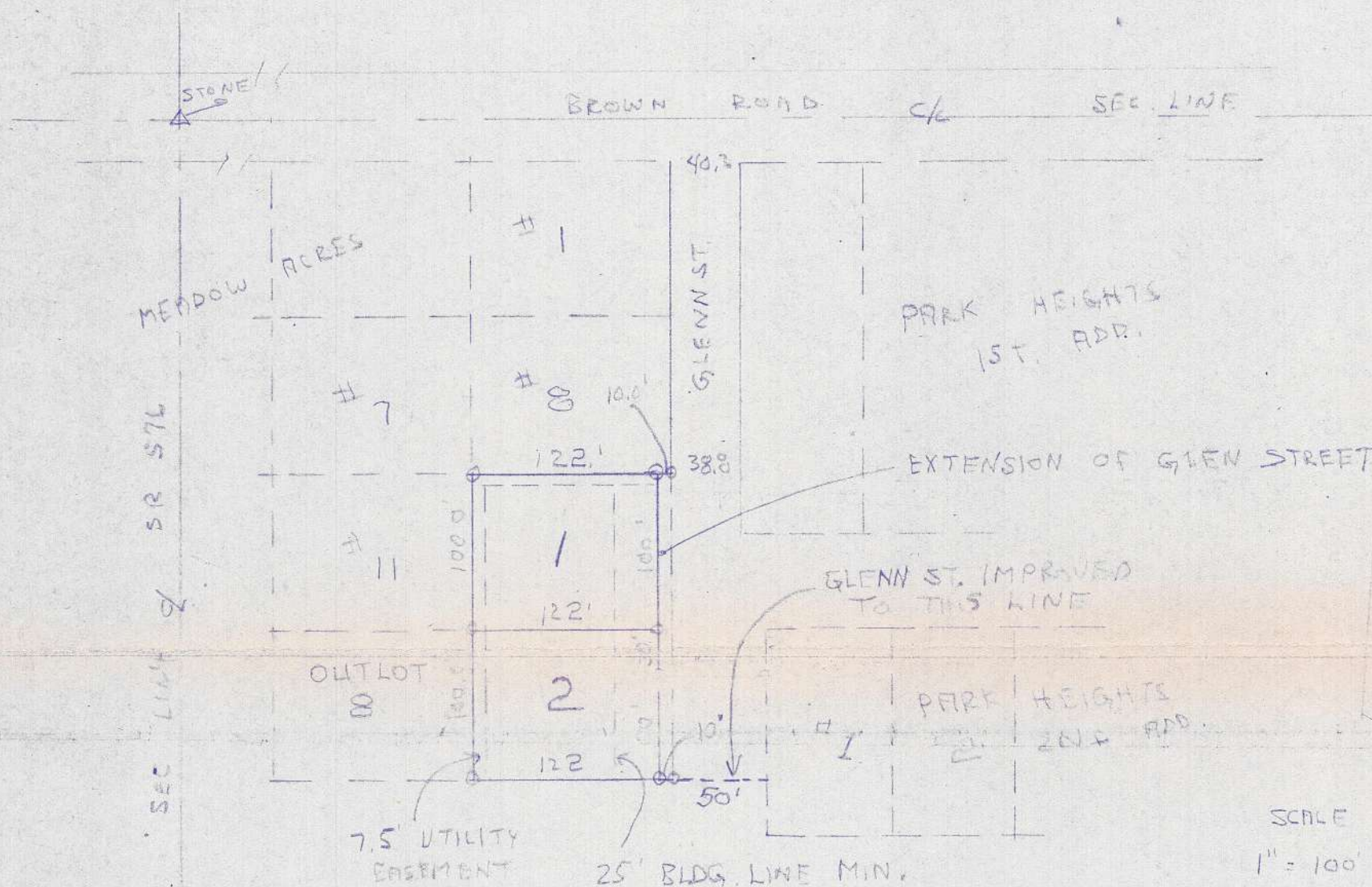


PARK HEIGHTS 3RD ADDITION
